Equipment Loan Agreement [ELA].

I accept that, if during the course of this trial, any products or accessories are lost or damaged we will accept an invoice for immediate payment at the your list price stated on this agreement. I understand that the product is available for a maximum loan period of 14 days unless otherwise agreed from date of delivery to you to the return date.

You ("the Borrower") agree that we (Burnside Telecom Ltd) loan the Equipment listed above to you on the following terms:

1. Use of Equipment

You will use the Equipment solely for your own direct use in connection with the Permitted Purposes listed above. You will comply with any instructions we give you concerning the use of the Equipment.

2. Return of Equipment

At your expense, you will return the Equipment to us at our address printed above on or before the Return Date in substantially the same condition (fair wear and tear excepted) in which you received it.

If you do not return the Equipment on or before the Return Date then you will have to pay for all our resulting losses and expenses including without limitation our costs of getting the Equipment back from you and our costs of arranging for the supply of similar equipment until we receive the Equipment back from you. You agree that we (or our agents) may enter your premises in order to recover the Equipment after the Return Date.

If, when you return the Equipment to us, it is not in substantially the same condition (fair wear and tear excepted) in which you received it then you will have to pay for the cost of repairing the Equipment or, if we decide that a repair is not practical, for the cost of replacing the Equipment. **Please use original shipping carton when returning equipment.**

3. Title

The Equipment remains our property at all times and you must not do anything that might prejudice our title to the Equipment.

4. Risk and Insurance

All risk in the Equipment lies with you for the Loan Period. You must fully insure the Equipment for the Loan Period against loss or damage from all risks. You must provide us with evidence of such insurance if we ask for it. If you do not provide us with evidence when we ask for it then we may arrange for insurance on your behalf and you will have to pay us for it. You must notify us immediately if you make a claim under your insurance for loss or damage to the Equipment and you must pay the proceeds of any such claim over to us in full.

5. No Warranty

You acknowledge that the Equipment is provided as is without representation or warranty of any kind, express or implied. Nothing in this Agreement shall exclude or limit our liability for death or personal injury caused by our negligence.
